According to the provisions of Article 27 of the Statute of UBT College and the Regulation on the organization of studies, the Steering Council of UBT approved this:

## DECISION

- I. The tuition fee for the Bachelor level is €1200, while for the Master level €1500 (this value is valid for one academic year), for the academic year 2019/2020 in all study programs (exception to this discount have the Pharmacy and Dentistry programs in which the amount of payment for an academic year is in the amount of 4000 Euros)
- II. For the academic year 2019/2020, UBT College offers scholarships discount on the registration price for studies according to the following criteria:
  - Students with excellent success, 20% discount (for the first academic year of studies, the same scholarship continues only for students who in the regular exam deadlines have completed all the exams of the respective year with an average grade of 9.00 e above);
  - Students of war martyrs' families, 15% discount (for the study program as a whole);
  - Students employed in the Kosovo Security Force, 30% discount (for the study program as a whole);
  - Students employed in Kosovo Customs, 30% discount (for the study program as a whole);
  - Students employed in the Kosovo Police, 30% discount (for the study program as a whole);
  - Students employed in Public Institutions of the Republic of Kosovo, 20% discount (for the study program as a whole);
  - Students from the same family, 10% discount (for the study program as a whole);
  - Students enrolling in a group (over 5 people), 10% discount (for the study program as a whole);
  - Students enrolling in a group (over 30 people), a 30% discount for those who have excellent success from previous education, while 20% for others (for the study program as a whole);
  - Students who pay the full amount of the fee, a discount of 10% (of the amount paid for the academic year);
  - Students who pay the full amount of the payment and are beneficiaries of any of the scholarships of this decision, receive a discount of 5% (of the amount paid for the academic year);
  - Students who scored 100% in the national test and have all 5 in pre-schooling, 50% discount per academic year (for the first academic year of enrollment, the same scholarship is extended only to students who in



the regular terms of exams, have completed all the exams of the respective year with an average grade of 9.00 and above);

- Students who enroll in UBT and are not citizens of the Republic of Kosovo (Presevo, Medvedja, Bujanovac, as well as from Montenegro) have a discount of 20% (of the amount paid for the academic year);
- Students who enroll in the branches of UBT (UBT Centers and offices in the regions) receive a discount of 20% for studies in total.
- Participant students of the pre-preparatory program, 20% discount (for the study program as a whole);
- The Rector reserves the right to approve special cases of deductions.

III. The student, who during studies loses the criteria of which he has benefited the scholarship, returns to the basic payment defined in the first paragraph of this decision.

IV. The above stated discount does not apply to the Dentistry and Pharmacy programs.

V. The student who meets the above stated criteria, has the right to only one of the discounts (except when the student is a beneficiary of any of the discounts listed above and does the full payment for the academic year, benefits 5% additional discounts), and two or more discounts cannot be applied at the same time.

VI. The payment of the amount of studies for the academic year 2019/2020 is made with a maximum of 12 equal monthly installments, in which case the student pays the first two installments upon registration, while the rest is divided into equal installments.

VII. For the implementation of this decision is charged the UBT Service.

VIII. The decision is validated on the day of its signing.
