Research activities:	Since small businesses have an extraordinary contribution to the
	development of Kosovo, it is observed that they often have difficulties
	in accessing finance, this applies mainly to small businesses and start-
	ups. The MBE Faculty will conduct a research to identify the main
	difficulties that these entrepreneurs encounter during their approach to
	financing. Access to finance is a key to starting, developing and
	growing a business for small businesses and startups, and those have
	very different needs and face different financing challenges compared
	to large businesses. The lack of capital invested in small firms makes

	these enterprises more dependent on other sources such as bank
	lending and other types of financial products. This research will
	identify the challenges of these businesses in accessing finance as well
	as offer the necessary recommendations for these businesses to have
	more knowledge in this field. The small businesses will be surveyed
	and asked about their level of knowledge about the possibilities of aces
	to different types of financing, and we will identify the main
	challenges and offer our recommendations. The research will be
	focused in all the territory of Kosovo and will be conducted by MBE
	students guided by professors.

Research Project	The Impact of Government Expenditures on Economic Growth:
	An Empirical Assessment for Developing European Countries.
Research description:	Government spending represents a very important indicator of aggregate demand, which could directly affect economic growth. Government spending has played a very significant role during periods of financial crises and economic instability. Therefore, the main goal of this research project is to analyze the relationship between government spending and economic growth in developing European countries. Given that in recent years there has been a tendency to increase the level of government spending due to the spread of the covid-19 pandemic and the armed conflict between Russia and Ukraine. Based on these parameters, European countries were forced to increase the level of government spending to support the budget deficit and public debt. The results of this research will also be discussed during the summer academy which will be organized during the month of July (2023) by the MBE Faculty, which includes a large number of local and international participants.

RESEARCH BUDGET

The research coordinator together MBE research committee provides to the dean the proposal for financing. The extent of financial sources for research is determined through the College's budget approved by the UBT.

The Dean of the respective department and the Institution director are responsible for follow up and check up on the project progress being carried out within the department and institution.

Below has been presented the financial allocation for of the implemented projects:

The financial part of the realization of the research projects is realized according to the dynamics of the implementation of the project and in the 3 (three) phases.

- 30% in advance form after the approval of the project;
- 40% after the completion of the first phase of the project;
- 30% after submission of the final report.

Faculty of MBE regularly organizes international conferences and summer academy every year. International Conference on Management, Business and Economics (ICMBE), is part of the UBT International Conference for Business, Technology and Innovation. The aim of the conference, is to facilitate the exchange of knowledge between innovative academics, doctoral candidates, post-graduate students, young researchers, researchers and industrial experts and to share views and experiences in the field of management, business, economics and other related areas.

The MBE Faculty recognizes the all scientific activities of academic staff according to the manual of Ministry of Education and Technology when at least one of the author has defined affiliation as UBT.

All papers accepted for presentation will be published in peer reviewed conference proceedings and also, they will be hosted on-line on our conference website. The presented papers will be further considered for possible publication in International Journal of Business and Technology (ISSN 2223-8387), Simulation Notes Europe (ISSN 2306-0271) and other partner and related journals. The published articles will be provided a DOI number by UBT.

UBT knowledge Center is the platform that UBT tracks the publications and research outcomes of its academic staff. UBT Knowledge Center is established in 2017, as one of the main pillars of UBT. The aim of the Knowledge Center is capturing data to produce information and create knowledge. Knowledge Center consists of three essential parts: A digital environment to advance local knowledge visibility. An organizational environment to enhance boundary crossing collaboration, A digital academic library environment to enable discovery of and access to published academic scholarship.

All researchers should publish in a peer-reviewed journal at least every three years on average. Individual research productivity should be appraised in relation to the share of working time designated to research according to the terms of employment.

RESEARCH INFRASTRUCTURE

UBT library consists of two separate spaces: spaces, which contained space for books and the space for reading. This separation enables the delivery of a more efficient service, opportunity for access to books and, at the same time, tranquility necessary and sufficient in the reading room.

The current physical library is depicted with its stacks of more than 300,000 books, one of the biggest libraries around, as well as its e-books and publisher databases. The librarians present work with physical books and digital material, including cataloguing and circulation, are illustrated at the left of the sphere named 'core knowledge'. UBT students have access to different digital e-

Libraries, such as BIONE, EBSCO HOST, IMF, Cambridge Journals and JSTOR. In addition, in our IT laboratories, the software's required to do research are available.
